### FY18 Tithe

US Habitat affiliates send at least 10% of their undesignated revenue to developing countries where Habitat builds. This money, or tithe, supports hundreds of people in countries such as Haiti and Ethiopia, in addition to homeowners served locally. In FY18, Minnesota affiliates and Habitat Minnesota tithed over \$480,000, bringing strength, stability, and independence to families all over the world and moving toward Habitat's vision of a world where **everyone** has a decent place to live.

#### FY18 National Statistics

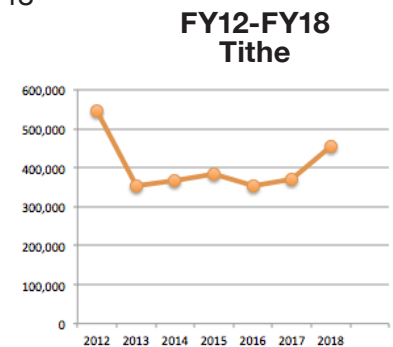
- **\$14 million** tithed

#### In Minnesota

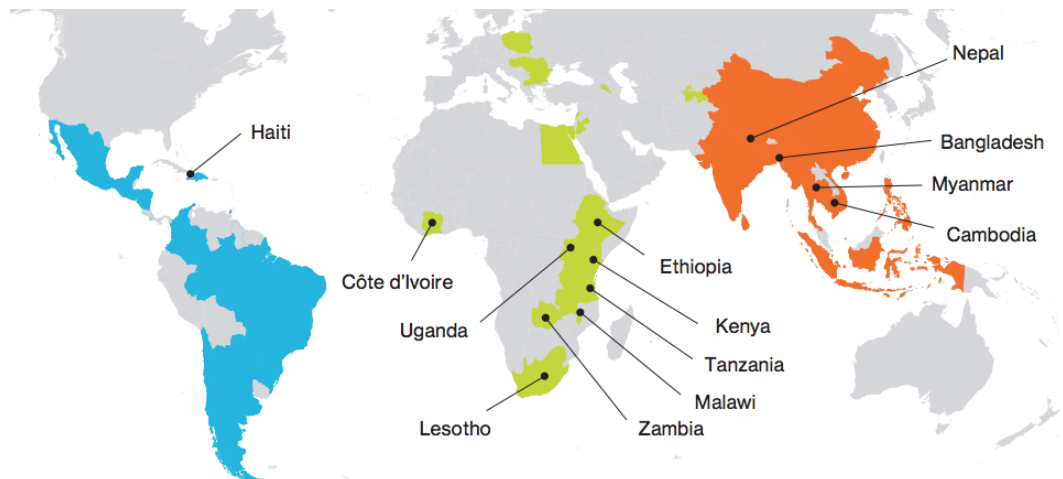
**\$486,276** tithed in FY18

## 40 Years of Tithe

40 years ago, Sam Mompongo, a local leader in today's Democratic Republic of the Congo, took up a collection during a home dedication. He presented half the money to Habitat for Humanity founder Millard Fuller, to be used for Habitat work elsewhere in the world. Fuller took the money to begin work in Guatemala. Forty years later, US Habitat affiliates have tithed more than \$272 million, serving nearly 85,000 families.



Habitat Minnesota and the Habitat 500 Bike Ride have supported a Habitat Philippines home building project for employees at the Children's Shelter of Cebu for eight years through tithe. On October 27, 2018, 63 new homeowners received their keys (top photo). Several of their homes are pictured in the bottom photo.
